# Career Brief

Dr. Wissoker is an economist focusing on health and labor policy research, with expertise in statistical and survey methods. He serves as an internal consultant at the Urban Institute on a variety of analytic and sample design issues. In this role he designed the samples for a survey of American Indian and Alaskan Native housing on tribal lands for HUD and a survey of Food Distribution Program on Indian Reservations for FNS. He also formulated the survey sampling designs for a survey of principals and teachers at schools operating a pay-for-performance plan funded through the Department of Education's Teacher Incentive Fund program and a World-Bank sponsored survey of coastal fishing households in Sierra Leone.

In his methodological work, Dr. Wissoker has conducted research on nonresponse bias and of noncontact in large household surveys. In 2001-2003, he was a visiting senior researcher at the Central Bureau of Statistics in Israel, where he studied non-response to the Israeli Labor Force Survey. He analyzed the quality of data in the Synthetic SIPP/IRS files for the Social Security Administration. He has taught trainings on "Practical Statistics" and "Regression for Policy Research" for USAID projects to develop capacity in Bosnia and Herzegovina and Azerbaijan and modules on sampling and regression at George Washington University.

Dr. Wissoker's research has covered a variety of topics and methods. In his health policy research, he is studying the potential for a consolidated Medicare prospective payment system for post-acute settings. He co-developed the sampling and analysis design for an audit study of access to physicians before and after the Affordable Care Act. In his labor-related research, he has analyzed the results of welfare reform, including large-scale evaluations for Washington State and Massachusetts, the effects of working for a temporary agency using propensity-score matching, and discrimination in entry-level employment using paired testers. Recently, Dr. Wissoker was responsible for the econometric analysis for HUD's paired testing studies of racial discrimination in both rental and sales housing. He co-developed designs for studies of discrimination in rental housing based on disability, presence of children, gay and lesbian couples, transgender persons, and source of income.
